## Home health telehealth services

The bulletin pertains specifically to AmeriHealth Caritas Delaware home health providers.

In response to the COVID-19 public health emergency, AmeriHealth Caritas Delaware is temporarily expanding its telehealth policies to broaden access to telehealth services. AmeriHealth Caritas Delaware will reimburse telehealth services provided by home health agencies. Telehealth (virtual) services include both video and audio. Coverage limitations will apply.

- \* G0156 Home health aide services provided virtually and/or telephonically will not be reimbursed as services typically require hands-on assistance with activities of daily living (ADL). If there is a circumstance where the ordering provider agrees, prior authorization will need to be obtained and approved for a virtual telehealth visit.
- \* G0299/G0300 Telehealth skilled nursing services are reimbursable if a member qualifies for appropriate preventive and rehabilitative nursing procedures. An in-person home health visit must be provided between telehealth visits. Example: A supported virtual visit where the caregiver would be given instructions on how to perform a task.

#### Additional information

- AmeriHealth Caritas Delaware will not reimburse providers for telephonic physical therapy, occupational therapy,
  or speech-language therapy (PT/OT/ST) visits completed over the telephone. PT/OT/ST visits must be completed
  virtually via an interactive telecommunications system.
- As stated in the CARES Act, telemedicine cannot take the place of ordered in-person visits. A Start of Care
  assessment should be done in person to establish a home health episode. If deemed appropriate by the home
  health agency, an observational-only recertification assessment may be performed through a virtual visit.
- The use of Skype or FaceTime for telehealth treatment or diagnosis purposes during the COVID-19 public health emergency is permitted when deemed appropriate using the provider's medical judgment and delivered within the definition of the code billed.
- **Exclusion:** Supervisory visits, as part of the homecare plan, may be performed virtually or telephonically. This is not a separately billable service but is inclusive of the service.

Providers are responsible for ensuring the submission accurate claims in accordance with AmeriHealth Caritas Delaware's reimbursement policies.
